

Fund objective

The Saudi Stock Exchange "Tadawul" by achieving a positive relative return compared to the indicative index, which is the BMK Index and Standard & Poor's for initial issues. The unit owner can obtain index information through the fund manager's website. The fund has the right to invest the cash available to it in money market tools and funds and funds Initial and licensed issuances from the Saudi Capital Market Authority. In addition, the fund will not distribute any profits to the unit holders, but all profits collected will be reinvested in the fund, which will be reflected in the unit price of the fund.

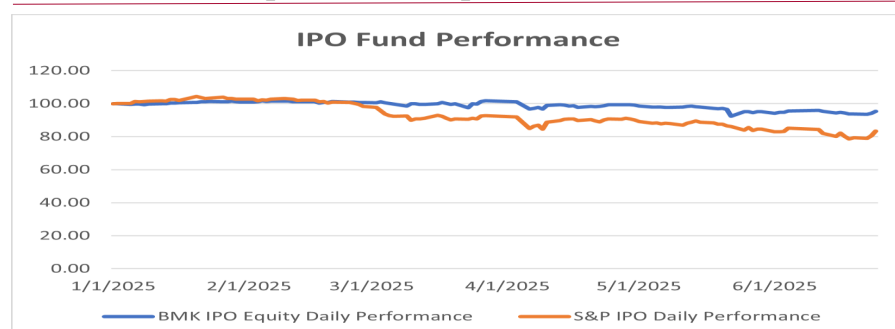
